Valley View Estates AGREEMENT GUIDELINES 209.0062 (d) Texas Property Code

- 1) There will be a bookkeeping fee of \$4 per month in addition to the agreed upon payment.
- 2) There will be a one-time agreement filing fee with the county of Hidalgo of \$40.
- 3) If the agreement is broken by lack of payment, the remaining assessment will be due upon demand, within three days, paid in full.
- 4) The monies may be paid in cash or good check directed to Membership, 2100 Vernon St. Mission, Texas 78572.
- 5) As an alternative, the cash or check may be deposited in the library drop box, located at 2100 Vernon St. Mission, Texas 78572.
- 6) An envelope containing payment post marked on or before the due date shall be considered, payment on time.
- 7) The agreement must be signed by <u>ALL</u> persons listed on the deed of record, in the county of Hidalgo, state of Texas and a current officer of the VVELOA.
- 8) Lack of payment, by the agreed upon date plus three days, shall begin accruing penalties listed in the association by-law.
- 9) There is no penalty for early payment or payment in full.
- 10) Any statement or statements of the agreement that are found to be in conflict with the Texas Property Code, shall be changed to conform to that code. (TPC 209.0062)
- 11) The filling fee is non-refundable and must be paid up front in total.

12) Caution: Should the payment period extend into the next calendar year; the contract will not preclude the assessment of or for the year next and the signators are prohibited from additional agreements for a period of not less than two years if the owner/s fail to honor the agreement.
